- 1111 Woman Cell of the colleges should organise seminars and talks where students can be made aware of their rights against Sexual Harasyment and in case of violations of these rigths, the redressal system should be provided. The details of each committee be displayed on the Nobice Board of the college
- It is the duty of the Head of institution and other responsible persons to prevent W or deter the commission of Acts of Sexual Harassment and to provide procedure. for the redressal by taking all steps required


