1. EXECUTIVE SUMMARY

1.1 INTRODUCTION

Government College Kosli was established in 2012 with the motto of spreading education at grass-root level, to be able to create better human beings. Our college is situated in rural area and having a green campus which spreads across 4500 sq meter. The institute has total 27 faculty members, including Principal, 17 regular employees and 09 extension lecturers. The college staffs members possess highly educated professionals degrees. The campus is well equipped with well-ventilated classrooms, a resourceful library, computer, math and language labs, smart class room, conference hall ICT facilities for integrated and advanced learning and a campus wide lease line internet. These facilities, amongst few others, provide the students very suitable atmosphere to expand their prospects to attain success in their life. The college cultivates democratic values on campus through various activities, including-forming a College Council, various committees and cells to exercise freedom of assembly and speech, inclusiveness and equality, consent, and voting. The college has provided Women Cell, Legal Literacy Cell, Anti Sexual Harassment Committee and a common room to the girl students so that they can realise what their rights are and how they can be effectively practiced, without getting marginalised. Our commitment to quality education is reflected in our highly qualified, competent and dedicated staff members who not only impart education, but in the process also inculcate moral values in students. Our institution, provide unparalleled experience to the students by pushing the boundaries of human knowledge.

Audio-visual aids, conferences, seminars, group discussions, and interaction with other agencies regarding the current issues of significance for creating the awareness among the students. College promote women empowerment programmes for strengthen the women and creating gender equity. With its core value of devotion to leading one towards understanding the virtue of truth, the mission of the College is to create a symbiotic relationship between the faculty & students, to be able to produce ideal citizens empowered to partake in the process of economic growth within a value system.

1.2 Strength, Weakness, Opportunity and Challenges(SWOC)

Institutional Strength

The college, established in 2012, is located in lush green prostrate and clean campus, has a newly built building with adequate infrastructure such as Conference Hall, Science, Computer, Language and Math Lab, ICT enabled Smart classrooms and Library for effective learning process. The college also provides other facilities like Common Room for girls, sports facilities with enough sports infrastructure, library, vehicle parking, and lawns, hall, milk booth, competitive cell for the students for their spare time. College is also providing Wi-Fi campus despite being in a rural area, so the students don't have to compromise on their learning process as compared to those in the cities. The teaching faculties are highly qualified and appointed as per the UGC norms and State Govt. of Haryana. Around 19% of our college fraternity is holding doctorate degrees in various streams. The College observes transparency in admission process through online mode, regulated and monitored by DGHE. Our institution and all the staff members are persistently labouring hard to provide maximum benefits to our rural students. Our commitment to foster students is that is not only academically superior, but also has good moral values.

Institutional Weakness

As our College is situated in remote rural area, the transportation facility for few of students from villages is one of the main bars. Non-teaching faculty is available through outsourcing scheme. Proper trainer in physical education is not available in our college. Ours is Government College and for its infrastructure augmentation largely depends on government funding and grants so there is a time lag between the planning and receiving of the funds. This creates irrelevant delay in execution of plans.

Institutional Opportunity

We have an ample opportunity to excel in sports also as our students come from rural area, comparatively interested in sports and can represent state and nation at various levels. Students of this college have brought laurels to this institution through their achievements like Women Kabaddi Team won 3rd position in State Level Inter College Kabaddi Championship held at GCW Rewari in 2021; Badminton Team (Men & Women) won 1st position consecutively for the last 2 years in Inter-College University Championship held at Raj International School, Rewari. Students from Basketball, Badminton & Kabaddi team participated in All India Inter University Championship for the last few years. College provided opportunities to the students to enrich their scientific temperament by allowing them to participate in Science Exhibitions. Science Models of many students of the college have won positions in Science Exhibitions held at various Government colleges in past 5 years.

Institutional Challenge

The inspirational values are found to be subsidized among rural students to access to education and learning process to equip them with knowledge. The teacher turn over issue is very high in rural area. Largely, the students due to their social background prefer traditional courses to professional courses. Institution is facing shortage of Teaching and Non Teaching Man power since starting i.e. 2012.

1.3 CRITERIA WISE SUMMARY

Curricular Aspects

Government College Kosli ensures effective curriculum planning and delivery through a well-planned and documented process including Academic calendar and conduct of continuous internal Assessment. Institution integrates crosscutting issues relevant to Professional Ethics, Gender, Human Values, Environment and Sustainability into the Curriculum. A wide range of General Electives, Skill Enhancement Courses, and Ability Enhancement Compulsory Courses are offered both within and across departments, to help students critically examine issues regarding gender, human values, environment, and ethics. To enlighten the students about social evils and to promote gender sensitization in our college, the Women's Cell has conducted several extension lectures throughout the term.

Teaching-learning and Evaluation

Government College Kosli is an emerging educational institution in the rural hinterland area of South Haryana. The student enrollment shows the continuous increase since it's establishment in 2012. The number of sanctioned seats are also increased after observing the enthusiastic response of the students for enrollment in the college. During the admission percentage of seats filled against seats reserved for various categories like SC, ST, OBC, Divyangjan, etc. as per applicable reservation policy of the government. Teacher – Student Ratio is appropriate. Student centric methods, such as experiential learning, participative learning and problem solving methodologies are used for enhancing learning experiences using ICT tools connected with Hi – speed internet. Mechanism of internal/ external assessment is transparent, students friendly, time bound and as per the University guidelines to which the college is affiliated. Programme Outcomes (POs) and Course Outcomes (COs) for all Programmes offered by the institution are stated and displayed on website and attainment of POs and COs are evaluated timely. A feedback system from students is also set up both online and offline mode.

Research, Innovations and Extension

NAAC comprises a variety of extension activities through various committees/cells such as women cell, NSS, YRC, legal literacy, nature interpretation cell and cultural committee etc. through which numerous activities have been organized like speech, declamation, poem recitation, poster making, slogan writing competitions, camps, rallies, Nukkad Nataks etc. for awareness among students and society for swachh Bharat, AIDS awareness, gender issues. The college has structured various mentor groups to different mentoring charges for further guidance of students in their future. Further, women cell and placement cell involving career opportunities works for students bright carrier and women empowerment in society by organizing lectures,

seminars and workshops in various fields for their self dependency. College teachers have published various research papers and book chapters in UGC approved; peer reviewed and well recognized journals. Teachers have also participated and presented papers in various seminar/National and international conferences.

Infrastructure and Learning Resources

The College has ample infrastructural facilities and learning resources to cater to the diverse academic needs of the students. The college is spread over a campus of 11.73 acres with 4750 square meter built-up area. There are 12 well-equipped classrooms including 04 smart classrooms with advanced IT facilities. All classrooms are spacious and well-ventilated. The institution has Computer lab, Language lab, Mathematics Lab, Multipurpose Hall and Conference Hall; all equipped with latest technology. The college has Physics Lab Chemistry Lab, Botany Lab, Zoology Lab and Geography Lab. The college has five water coolers with RO facility to provide 24 hours safe drinking water facility to students. The college has ICT facilities and learning resources for academic and administrative purposes. The college has connection to a leased line with a bandwidth of 50 MBPS. There is a well-stocked and well-furnished library which is enriched with a wide range of books including text books and reference books of various subjects and disciplines, general books, competitive examination books and dictionaries of Hindi and English. The library has subscription of INFLIBNET N-LIST to access online books, journals and other e-resources. The facility of Newspapers and magazines is also available for students and teachers. The whole college campus is fully wi-fi enabled and under CCTV surveillance

Student Support and Progression

The college Support Students through different kinds of stipends and scholarships (Merit, SC, BC, Freedom Fighters, Minority scholarships etc.) under various schemes of the Government of Haryana. Financial assistance is given to the students under the "Earn While You Learn" scheme for working in the college for fixed hours. Many activities are organized by different departments, subject societies and cells on the college campus which motivate and encourage students for maximum participation in co-curricular and extra-curricular activities. Students who excel in quizzes, debates and discussions, sports, and cultural activities are provided cash prizes and awards along with appreciation and merit certificates. There is a Career Counseling and Guidance Cell/Placement Cell, which guides and instructs students about career opportunities and competitive exams. It provides information related to admissions and jobs through its display on the notice board. It also acquaints them with various career options through participation in job fair. The institution has a transparent mechanism for timely redressal of student grievances including sexual harassment and ragging cases.

Governance, Leadership and Management

The governance and leadership of Govt. College Kosli is in accordance with vision and mission of the institution and it is visible in various institutional practices. The institution is working continuously and efficiently for providing values addition and to create excellence in various perspectives, dimensions, and domains through the propagation of qualitative, innovative, and object-oriented education among students of rural areas. The college promotes a culture of decentralization and participation in institutional governance at different levels. The college promotes a culture of participative management through the involvement of all the faculty members in one or the other committee or the designated cells. The College administrative setup is headed by Principal and is assisted by the college bursar and the conveners of the various committees. The

College Council is a statutory body that implements decisions of the Governing Body related to academic, extracurricular, and infrastructural activities through its various committees. Internal Quality Assurance Cell (IQAC): IQAC is a UGC mandated body to ensure quality improvement in the field of academics, planning, and administration of the institution. It lays down quality benchmark in the various matters. The College has a Grievance Redressal committee to address the grievances of all. Institutional Development Plan of the college with specific targets for the desired outcomes is prepared regularly. Administration, Finance and Accounts, Student Admission and Support, and Examination are primarily governed by e-governance. The institution has effective welfare measures for teaching and non-teaching staff like Medical Reimbursement, Child Care Leave, Casual leave etc. Faculty members honed their skills by participating in Faculty development Programmes (FDP), professional development/administrative training programmes etc. All the quality assurance mechanisms across academic, planning and administration are governed, implemented and supervised by the IQAC.

Institutional Values and Best Practices

The college takes pride in its decentralization of powers in which all the staff members enthusiastically participate in the betterment of the students and the institution. At the beginning of each session, the staff members are assigned different duties according to their abilities, aptitudes, interests and experiences etc., through forming of administrative committees. These committees follow the guidelines/instructions of the Directorate of Higher Education in matters of finance and organisation of events. All the works related to finance, administration and academics are undertaken by these committees in a transparent way. Resource persons are invited by the college to deliver extension lectures under placement cell and women cell. The college suffers from an acute shortage of regular supporting staff to look after the lawns and water plants, plant new saplings, prune the old trees and shrubs etc. The non-teaching staff members, along with teaching staff members, voluntarily and enthusiastically participate in the maintenance of the lawns in the college. Further, the incharge of NSS motivates the students to join these extension activities as volunteers. These volunteers plant saplings, water the plants, prune hedges, and maintain the lawns by putting in a lot of physical hard work. During the organization of camps and regular social service provided by NSS, the volunteers are free to take a decision on their own under the intelligent guidance of the coordinators of these extension activities for the maintenance of lawns and part of campus allotted to them. In this way, these volunteers make the college campus green to maintain Ecosystem. This also helps the college administration to face a shortage. College is ready to implement the NEP-2020 as and when the I.G.U. Meerpur, Rewari will implement the above policy. Institutional preparedness for NEP

1. Multidisciplinary/interdisciplinary:	A 07-day workshop has been conducted by the college from 04.01.2024 to 11.01.2024 to orient all the faculty members about Multidisciplinary/Interdisciplinary approach in NEP 2020. Administrative body, academic staff and non-teaching staff members of the institute are ready to implement NEP 2020 in letter and spirit.
2. Academic bank of credits (ABC):	Academic Bank of Credits (ABC) IDs of all the enrolled students have been generated w.e.f. current academic session. All the students have been briefed about the importance of ABC ID in NEP 2020. The same has been forwarded to Indira Gandhi University, Meerpur, Rewari for further necessary action in this regard. In future, the college authorities will take the required steps to apprise the students about how to earn credit scores and utilize them in pursuing higher education.
3. Skill development:	Ultramodern Language Laboratory has been installed in the college to instill Soft Skills in the students. Many workshops have been conducted by the Placement Cell of the college to orient the students about the role and importance of Soft Skills in Corporate world. Students are regularly taken to the job fairs held in the locality.
4. Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course):	All the faculty members of this college are tech savvy and are using advanced teaching tools in taking Online classes of the students. During Pandemic time, Online classes were successfully conducted by the faculty members. Concrete steps will be taken by the institute to promote the teaching of Indian Languages and design the curriculum in vernacular languages. Regular Induction of the students is done by the institute through various outreach programmes to orient them about rich cultural heritage of our nation.
5. Focus on Outcome based education (OBE):	This institute is fully dedicated to focus on the Outcome based education. Innovative and creative ways of evaluation will be used by the teachers after implementation of NEP 2020. Focus will be made on the all-round development of the students. Innovative pedagogy with due emphasis on the Practical aspects of learning will be used.
6. Distance education/online education:	Administrative efforts will be made to get the permission of Higher Authorities to start appropriate

courses through Distance Learning. Online mode of education will be promoted by designing online courses. Support from the locality will be obtained to achieve this aim.

Institutional Initiatives for Electoral Literacy

1. Whether Electoral Literacy Club (ELC) has been set up in the College?

Yes, Electoral Literacy Club (ELC) has been set up in the college. Since starting of this college ELC has been working with full potential to orient the students about role and importance of casting votes for dynamic democracy. Form-6 of eligible students is filled up by the ELC staff of the college and the same is dispatched to respective District Election Officer for generation of EPIC. Dr. Vivek Kumar, Associate Professor and Dr. Vandna Nishal, Assistant Professor are the Convener and member of ELC of this college respectively.

- 2. Whether students' co-ordinator and co-ordinating faculty members are appointed by the College and whether the ELCs are functional? Whether the ELCs are representative in character?
- Yes, all faculty members and N.S.S. volunteers have been appointed by the college administration as members of ELC. Various types of voter's awareness programmes like Voters' Oath taking ceremony, declamation, slogan witting, poster making contests etc. are regularly organized and voters awareness rallies are organized to create sensitization among local population to cast votes in elections.
- 3. What innovative programmes and initiatives undertaken by the ELCs? These may include voluntary contribution by the students in electoral processes-participation in voter registration of students and communities where they come from, assisting district election administration in conduct of poll, voter awareness campaigns, promotion of ethical voting, enhancing participation of the under privileged sections of society especially transgender, commercial sex workers, disabled persons, senior citizens, etc.
- All students of the college are oriented by the ELC members to cast their votes without taking consideration of caste, religion, gender, regional factors etc. in upcoming General Elections 2024. Students are encouraged and motivated to get their names registered in voter list. Student Volunteers of the college have assisted District Election Authorities in the past for smooth conduction of polls, helping disabled voters to convey them to polling booths etc.
- 4. Any socially relevant projects/initiatives taken by College in electoral related issues especially research projects, surveys, awareness drives, creating content, publications highlighting their contribution to advancing democratic values and participation in electoral processes, etc.

Awareness drives have been launched by the college to enhance the participation of students in election process and getting registers in electoral roll.

Motivation lectures by the specialists have been conducted to spread awareness about role of voting in democracy.

5. Extent of students above 18 years who are yet to be enrolled as voters in the electoral roll and efforts by ELCs as well as efforts by the College to institutionalize mechanisms to register eligible students as voters.

Less than 50 students are yet to be enrolled as voters. ELC members are in the process to get them also registered in electoral roll. List of eligible voters have been prepared and the same is monitored regularly for necessary action in this regard.

Mechanism of internal/ external assessment is transparent and the grievance redressal system is time-bound and efficient

Response:

The University level examinations are conducted in the college. University appoints the Superintendent and Dy. Superintendent, other faculty members are appointed as Assistant Superintendents by the college

Principal. The examination centers are checked frequently by the flying squads of the university and one full time observer to maintain the sanctity and impartiality of the examination. The answer sheets of the students are sent to the University, which assigns them fictitious Roll No's and sends them to different colleges for assessment. Once the result is published by the university, a time period of 15 days is given to the university to the students for applying for re-evaluation. The re-evaluation of the answer script is done by a different examiner. If there is a difference of more than 20% marks awarded by the two evaluators, the answer script is sent to the third examiner and the grievances are resolved in a time-bound and efficient manner. Internal assessment of the college strictly follows the university rules & procedures for internal assessment. Although the schedule of class tests and submission of assignments for internal assessment is fixed before the completion of each semester, the students are given their topics of these class tests as well as assignments well in advance. The following internal assessment criteria as given by the affiliated university are followed in the college. As per the University criterion, an internal assessment of 20 Marks in all UG classes has the following components:

1. Assignments= 5 Marks. 2. Class test= 10 Marks. 3. Attendance=5 Marks

6.4 Financial Management and Resource Mobilization

6.4.1

Institution has strategies for mobilization and optimal utilization of resources and funds from various sources (government/nongovernment organizations) and it conducts financial audits regularly (internal and external)

Response:

The College being DHE Maintained Institution, there are provisions for internal audits to be done by the Audit Committee of the college every year. However, an internal audit of the college is done by the office of the Director-General of DHE. Whenever any audit objection arises, it is noted for compliance and the head of the institution is informed. The Head of the institution then undertakes the required corrective measures. The seclude of audit is intimated to the college provides all the records to the audit team for their ready reference, if there is any objection that is timely complied with by the college. In addition to this, Stock Verification Committees are appointed by the Principal at the end of each financial year to check and verify the available stock. The external audits of the college are conducted regularly as per the state Govt. instructions. The audit team of Accountant General Haryana conducts periodical audits of the record of funds provided by the State Government. After the conduct of the audit, the Chief Accounts Officer, Govt. of Haryana, releases the audit report. The institutional mechanism to monitor the effective and efficient use of available financial resources areas given below: The Higher Education Department allocates funds and grants according to the demands and requirements made by the institute. The Principal of the institute discusses the requirements of different departments in the staff meeting and then utilizes the funds on a priority basis. The institute adheres strictly to the financial rules and regulations framed by the government regarding purchases and procurements. Different purchase committees comprising 03 senior members are constituted to purchase the items as and when required. The purchases are made preferably from GEM (Government e-Marketing) to maintain transparency.

- The purchase committee makes the required purchases by inviting quotations, comparison of rates and approval of the same by the D.D.O/Principal and supply orders are given to the firm quoting the lowest rates.
- The items purchased are procured and entered in the stock register after physical verification through the committee so as to ensure effective and efficient utilization of the funds.
- Some items like computers, printers, fax, Xerox machines, furniture and water coolers which

are directly sent by the higher education department directly, are then entered in the stock register.

- All the financial documents are checked by the College Bursar before making payments of bills by The Principal.
- Audit of Govt. Grants is conducted by A.G. Haryana and a report of the audit is available in the college office.
- The details of the major sources of institutional receipts/funding/grants are as given below:
- Funds in the form of specific grants are received from mainly from the Department of Higher Education, Govt. of Haryana.
- Fees and funds collected from the students are other sources of income for the institution.

6.5 Internal Quality Assurance System

6.5.1

Internal Quality Assurance Cell (IQAC) has contributed significantly for institutionalizing the quality assurance strategies and processes. It reviews teaching learning process, structures & methodologies of operations and learning outcomes at periodic intervals and records the incremental improvement in various activities

Response:

The Internal Quality Assurance Cell (IQAC) is a driving force for ushering in quality by working out intervention strategies to remove deficiencies and enhance quality. All the quality assurance mechanisms across academic, planning, and administration, which was earlier independently governed and implemented at different levels, is now supervised by the IQAC. The IQAC has initiated the process of the development of quality benchmarks for the academic and administrative activities of the college. Several initiatives such as the introduction of an institutional academic calendar, feedback system (covering several aspects of the institution), promotion to research, etc have been taken by the IQAC. From the very beginning of the institute, it emphasizes more on its Teaching-Learning process. All the teachers prepare their course structure and teaching plan according to the guidelines of DGHE Panchkula and it is well communicated to all the students. Still to ensure the quality of teaching and the learning level difficulties institute has developed two-tier feedback systems. It is a kind of satisfaction survey from the students for teachers regarding every individual subject they are teaching in the particular semester. All the students studying in the particular class give their feedback. It is ensured that at least 60% of students of the class are present at the time of online feedback. Depending upon this feedback individual subject teachers are advised to improve in their teaching methodologies. This type of feedback is taken on regular basis to assure the satisfaction of the students and to ensure the quality delivery by the teacher in the stipulated time frame. Now, according to the suggestions given by IQAC some of the parameters in the above feedback are modified and a new system is developed. It has recommended a grant of Senior Scale to Sh. Surender to Director of Higher Education in 2022. IQAC encourages staff members to undertake research activities, publications and paper presentations in Seminars/Conferences to enhance the quality of teaching. The institutional Development Plan has been prepared by IQAC as a road map for college development. The IQAC cell, Government College Kosli has organized online feedback from students about the college and teachers and analyzed them as feedback for quality improvement. The IQAC conducted a one day internal training course on NEP as a resource building for

the implementation of NEP from the next session. It encourages teachers to prepare lesson plans, and organization of extension lectures in the college so as to create a vibrant academic atmosphere. The drinking water facility through R.O., up gradation of labs, Veeta Milk Booth facilities etc. were some of the suggestions given by IQAC, which have been implemented, thus improving facilities for students.

- Project based learning leads to "Self Learning" system instead of "Educator Teaching" system.

Throughout the year, the NSS unit undertakes a plethora of events ranging from street plays, cleanliness drives, tree plantation drives, donation drives, waste management drives, gender equity, field visits and many more. The NSS unit has also been was also a part of the plastic recycling drive initiated by Bisleri which was successfully implemented in the campus. It emphasized on the topic: Plastic is not bad. The institute ensures that the social values and feeling of giving back to the society is not limited to the NSS unit. In addition to the activities by NSS, many students too come up with ideas to contribute to society too, and at GST, we encourage them to go forward by supporting them in executing the ideas. The students have conducted donation drives for flood affected people in the past. One of our students was a part of the CDAC team, which was developing robotic chairs for COVID wards in the hospitals. Students have also developed an app portal to spread awareness about COVID 19. Keeping in mind the concerns regarding mental health during the lockdown, the portal also served as a platform to showcase initiatives and experiences of students during the lockdown.

Along with other sports cultural and technical activities, the NSS unit plans activities like tree plantation and field visits to expose the students to the pressing issues in our society. Not only that, every first-year faculty member has completed a short-term course in UHV, they also interact regularly with the students through open discussions on various topics.
